"We are pushing/pulling our clients into the technology world, including client portals," Bruce says. "We have several clients who think it's the best thing since peanut butter, and then we have lots who just are not there yet. But we have a five-year goal to move everybody to the portal — if we could do that, I think we could increase our client base at least 30%, maybe 50%."

Abercrombie found stunning results when the firm started using FileCabinet CS, a document management solution from Thomson Reuters, designed for accountants. "If we can get them to scan and upload their documents themselves, that saves us so much time. Even if it just saves us 10 minutes per client, 10 minutes times 700 is a lot of time." Specifically, two weeks. What would you do with two more weeks of time in a year?

Their Practice CS firm workflow management software also paid for itself in three months or less, Bruce says. Its most important impact was demonstrating to Abercrombie and Bruce their own value. "It helped show how much time we were giving away," she says. "We weren't quoting people correctly because we didn't realize the time we were spending on things."

The sister CPAs also found success with Practice Forward, a subscription consulting and content offering that helps progressive firms reach their full potential. In just four months, Practice Forward increased the firm's revenue by \$49,500. "Practice Forward has helped us to bill for those services that we wanted clients to start using, but we couldn't get them on board because of price," Abercrombie says. "We knew there was value in that, but Practice Forward helped us to show the client the actual value they're getting."

Practice Forward also contributes to Integrity's capital by helping the firm set up monthly automatic clearinghouse (ACH) payments. "We want our small business clients to be successful, so we were willing to sometimes reduce their annual bill because we understood cash flow was tight for them at that time," Abercrombie says. "It's a lot easier for them to pay \$450 a month than it is to pay \$5,400 once a year. ACH has been key for helping us bill what we should."

Abercrombie and Bruce plan to keep growing Integrity and building on their success, using the right technology to make the best decisions for their firm. "Our goal is to hire another CPA to do the auditing and help during tax season," Bruce says. "For us, that's a big thing that Thomson Reuters products are helping make possible. One, it's helping us use our time more wisely. Two, it's helping us be way more efficient. So that we can do more ourselves so we can build the capital up in order to hire another full-time CPA."
