

Enhance and easily load Excel-based workpapers or tax packages into DataFlow where the requests can be sent via a familiar Excel data collection workbook.

Flexible data collection

Easily distribute and monitor data collection requests. Send automated and ad-hoc reminders to ensure timely completion. Documents and notes can be attached to data collection requests for improved communication and information gathering. Make updates to the

template at any time without affecting previously collected data. See changes in real-time within your data request, without sending a new version. This is particularly helpful if requirements change during the process.

- Once data is entered by the provider, it's never rekeyed, eliminating any chance of a transcription error.
- Eliminate version issues of tax packages sent out, ensuring that only one active workbook is in circulation.
- Store data in a central repository, allowing for easy review, consolidation, and scrubbing — all from Excel.

Simple data loading and reviewing

The Excel add-in feature within DataFlow makes loading data easy. It maps and transfers data across ONESOURCE such as into ONESOURCE Income Tax or Tax Provision — without ever needing to launch the software.

- Import scripted results from spreadsheets containing Macros or Visual Basic without having to remove those elements.
