Account holders access tax information using your institution's client-facing website. To use the service, log on with a password-protected user ID.

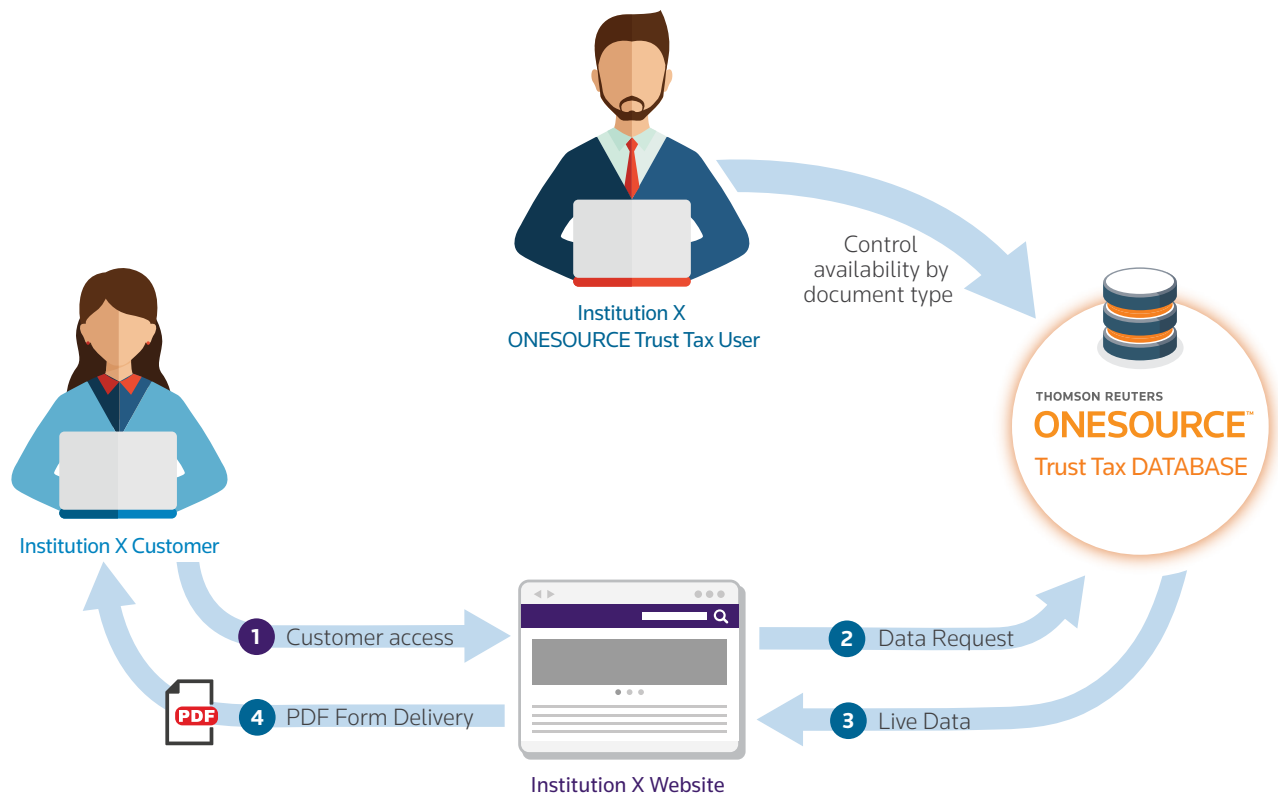
Links from your secure website enable clients to access tax documents for each account. They'll see a summary of available documents and can select and download to their computer for viewing, printing and saving.

HOW IT WORKS

Using our web delivery service, access to tax forms is completed using the client's current log on along with the authentication capabilities and security validation of your institution's website. You control the user website, messages to account holders and the tax documents that can be accessed.

Clients do not have direct access to ONESOURCE Trust Tax, they simply see a link on your website enabling them to retrieve copies of their tax documents.

RETRIEVING DOCUMENTS




Through ONESOURCE Trust Tax, you set the milestone indicating when each tax document type is available for retrieval by account holders.

When a client logs in and accesses a unique icon or link, your institution's website will access Web Delivery with special credentials. ONESOURCE Trust Tax returns a list of available documents for the client identified by type of document and date created. The data is converted into a PDF-formatted document and returned to your institution's website for display. To ensure privacy, and to eliminate the risk of identity theft, every document is fully encrypted.

Web Delivery is completely transparent. To retrieve documents, account holders simply log onto your website, click on an icon and download their tax information forms to their own computers to review, print, or save.
